### IMPORTANT UCC ANNOUNCEMENT

#### Surcharge Increased for UCC Filings Effective July 1, 2015

*Fees for Washington State's UCC services change on  
July 1, 2015:*

Washington's UCC filing fees will increase on 7/1/2015. The new fee for filing electronically will be \$18 and the new fee for filing by mail will be \$25. The new fees apply to all filing requests **received** in our office beginning 7/1/2015—regardless of post mark date. As always, we will return any filing requests submitted with insufficient payment.

The fee amounts include a surcharge that was increased by the 2015 Legislature. The surcharge funds a program to combat financial fraud and identity theft. *The search fees are not changing.*
